AdamsTM Plus Flea & Tick Shampoo with Precor® may be used full strength or diluted with 2 parts water. Thoroughly wet animal with warm water. Do not apply shampoo around eyes. Apply shampoo on head and ears, then lather; repeat procedure with neck, chest, middle and hindquarters, finishing legs last. Continue to work lather in for 3 to 5 minutes (this is an important part of the grooming procedure), then rinse animal thoroughly. For extremely dirty or scaly animals, the above procedure may be repeated. Repeat every 7 to 10 days, if necessary, for adult flea relief. Flea egg hatch inhibition will last for 28 days. Do not use on puppies or kittens under 12 weeks old.

STORAGE AND DISPOSAL: Storage - Store in a cool area **Disposal:** Nonrefillable container. Do not reuse or refill this container. **If empty:** Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency for disposal instructions.
