### **Antifungal Solution**

#### **CAUTION:**

Federal law restricts this drug to use by or on the order of a licensed veterinarian.

#### **INDICATIONS:**

For dermatological conditions associated with infections responsive to Clotrimazole.

#### **ACTIVE INGREDIENT:**

Clotrimazole 1%

#### **INGREDIENTS:**

Propylene Glycol, SD Alcohol 40, Cocamidopropyl PG-Dimonium Chloride Phosphate, Chloroxylonol (PCMX), Benzyl Alcohol.

#### **DOSAGE AND ADMINISTRATION:**

Thoroughly clean and dry the affected area before treatment. Remove foreign material, debris, crusted exudates, etc., with suitable non-irritating solutions. To prevent spreading and reinfection from fungal spores attached to hair shafts, clip the hair in the area of the lesion before and during the treatment period as needed. (Note: Disinfect clipper head before re-use.) Apply a thin layer twice daily. Therapy should continue for 14 consecutive days. Wash hands thoroughly after applying to avoid spread of infection.

#### **RESISTANCE:**

Resistance to clotrimazole is very rare among the fungi that cause superficial mycoses. Neither natural nor acquired resistance appears to be prevalent.

**SIDE EFFECTS:**

The following have been reported occasionally in connection with the use of clotrimazole: erythema, stinging, blistering, peeling, edema, pruritus, urticaria and general skin irritation not present before therapy.

**CONTRAINDICATIONS:**

If hypersensitivity to any of the components occurs, treatment should be discontinued and appropriate therapy instituted. Do not use in dogs with known perforation of eardrums.

**DRUG INTERACTIONS:**

None.

**WARNING:**

Keep out of reach of children. Avoid contact with eyes or mucous membranes. If contact occurs, immediately flush with water. If skin irritation occurs, discontinue use and consult a veterinarian.

**CAUTION:**

Sold only through licensed veterinarians.

Box of 12 x 30 mL (one fluid ounce) plastic bottles with dropper tip

**STORAGE:** Store at controlled room temperature.
