## Administration as a supplement for dogs:

The recommended initial administration period is four to six weeks; however, some dogs may respond in a shorter period of time. The number of scored chewable tablets may then be reduced to the maintenance level.

Up to 15 lbs.	1/2 daily	1/2 Every other day	
16-30 lbs.	1 daily	1/2 daily

Over 60 lbs.	3 daily	1-2 daily	

▲ Once consistent improvement has been seen, these maintenance levels may be reduced to an every other day administration. The maintenance level can also be used long term on healthy dogs to help support their joints.
