### **ALLERGY**

**INGREDIENTS:** Aqua, Capryl/Capramidopropyl Betaine, Diethylhexyl Carbonate, Polyglyceryl-4 Laurate, Phenoxyethanol, Dilauryl Citrate, Glycerin, Glycerol, Oat extract (Avena Sativa), Spent grains wax, Butyrospermium Parkii Extract, Argania Spinosa Kernel Oil, Saccharomyces Cerevisiae Extract, Ceteareth20, Phytosphingosine Chlorhydrate, Polyquaternium-51, Cholesterol, Sodium Lauroyl Lactylate, Carbomer, Xanthane Gum, Polyisobutene Hydrogene, Ceramide 3, Ceramide 6-II, Ceramide 1, Ethylhexylglycerin, Potassium Sorbate, Fragrance.

**USES:** for dogs and cats - adjunctive topical management of skin irritations. This product is intended to be used adjunctively in protocols for the management of skin conditions under the supervision of a licensed veterinarian.

**DIRECTIONS FOR USE:** Shake well before use. External use only. Brush the coat thoroughly. Apply on dry coat. Dispense one or two pumps in the hand and then apply the foam on the animal. Massage into the hair coat in order for the product to reach the skin. Repeat as many times as necessary to cover the whole body, avoiding areas around the eyes and mouth. Do not rinse. Let air dry. Once dry, the animal may be brushed again to bring luster.

### **DOSAGE:**

Under 11 lbs: 1 pump per 2 lbs

12-88 lbs: 1 pump per 4 lbs

Over 89 lbs: 1 pump per 6 lbs

Dosage can be doubled for long-haired dogs.

The veterinarian's recommendations should be observed. It is usually recommended to use Douxo Calm Mousse in protocol with Douxo Calm Shampoo.

One application every three days, alternating between the shampoo and the mousse.

**PRECAUTIONS FOR USE:** do not swallow. Avoid contact with the eyes. If contact with the eyes occurs, rinse thoroughly with water and consult a veterinarian. Keep out of reach of children. If irritations occur or increase, discontinue use and consult a veterinarian.
