Indications: Kills ear mites in dogs, puppies, cats, and kittens.

To Kill Ear Mites: Clean ear with an otic solution. Place a sufficient amount of MITA-CLEAR™ into each ear to thoroughly coat the surface of the ear canal. Gently massage the base of the ear. Leave lotion in ear for a few minutes and carefully wipe the excess lotion from the ear with cotton. Lotion to be applied twice at 7-day intervals.

Precautionary Statements: Hazards to Humans and Domestic Animals: Caution:

Human: Harmful if swallowed. Avoid breathing vapors. Avoid contact with eyes. In case of contact, immediately flush eyes with plenty of water. Obtain medical attention if irritation persists. If swallowed, do not induce vomiting. Wash hands with soap and water after using.

Animal: Avoid contact with eyes. If in eyes, flush with water. Do not use on puppies or kittens under 12 weeks of age. Consult a veterinarian before using this product on debilitated, aged, medicated, pregnant, or nursing animals.
