**Follow-up calendar based on recommended dosage**

**For use with dermatological conditions (red circle) - 1 packet per day (one box treats for 4 weeks)\***

\* 8 weeks of use may be necessary.

To be renewed in accordance with the recommendations of your veterinarian.

**For maintaining healthy skin and coat (green circle) - 1 packet every other day (one box treats for 8 weeks)\***

\* To be renewed in accordance with the recommendations of your veterinarian.

**Step 1 - Choose the circle that corresponds to the recommendations of your veterinarian.**

**Step 2 - Cross out the current day after giving the packet. The arrow indicates the next day where another packet is to be given.**
